- 1. Reports of the JSC "Conexus Baltic Grid" Board, Council, and the Independent Auditor.**
To take note of reports of the Board, the Council of the Joint Stock Company "Conexus Baltic Grid" and the Independent Auditor.
- 2. Approval of JSC "Conexus Baltic Grid" Annual Report and the Dependency Report for 2025.**
To approve Joint Stock Company "Conexus Baltic Grid" Annual Report for 2025 and the Dependency Report for 2025 prepared by the Board and reviewed by the Supervisory Council of the Joint Stock Company "Conexus Baltic Grid".
